

Statement of complaint

“Mr K.U Suman and Mr. Sri Harsha of I year II Semester MBA students have stated in their complaint letter that I Year II Semester B.Tech Mechanical students namely Mr. M.A.Amaan , Mr. Mohammad Arshad and Mr. Mohammad Shoaib are making noise without reason. And also stated that those students have created a society/group to solve the problems in college premises.”

The committee conducted an enquiry with the following students in the committee chairman's cabin on 30/04/2018.

He said that while Bhavitha and Avinash talking with each other, Mr. M.A.Amaan , Mr. Mohammad Arshad and Mr. Mohammad Shoaib have entered and interfered in their conversation near canteen around 3:45 PM on 23/04/18.

He said that He questioned them “why are you involving in MBA students issues”. He also said that those students told him that “they formed as a society/group to solve the issues in the college that is the reason for their involvement”, on 23/04/2018 near college gate(parking).

He said that Amaan forcing him to arrange a meeting with Harsha to discuss the matter.
- 4) **Mr Avinash (17R11EE0023) (I Year II Semester MBA)**
He said that Amaan came aggressively when he was consoling Bhavitha, who is weeping on her personal issues.



These students also gave a letter stating that they have done mistake by involving in MBA issues being a I year B.Tech students and they also mentioned that they didn't form any society/group in college to solve student issues.


Committee's Recommendations


Based on information available, the committee felt that those three students namely Mr M.A.Amaan , Mr Mohammad Arshad and Mr Mohammad Shoaib were involved in the MBA students issues unnecessarily, hence the committee recommends

1. To take disciplinary action against them.
2. To inform their parents about unnecessary involvement in other issues rather concentrating on their studies.




