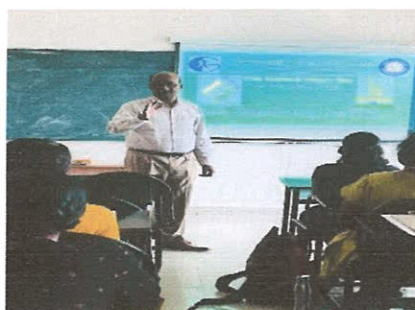

Aim & Objective:

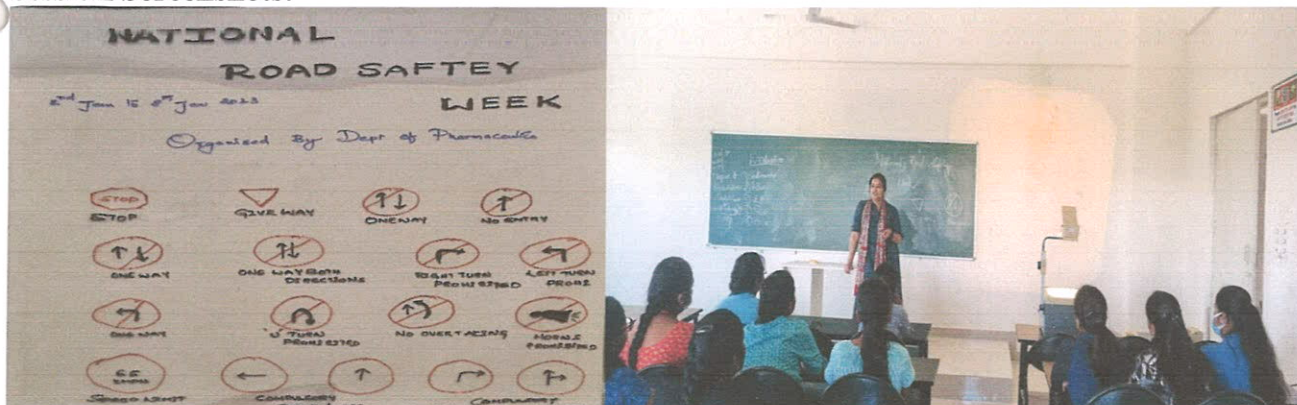

The primary purpose of this event is to emphasize and educate students about the importance of road safety rules. Students are educated on the basic symbols to strictly follow.

Expected outcomes:

Here are the essential road safety rules every driver and pedestrian must adhere to:

1. When behind wheels, always follow the red, green, and yellow light signals installed at crossroads, intersections, and zebra crossings
2. Stay to your left while walking, using a vehicle, or taking a turn.
3. Use hand gestures and signals to communicate with vehicles and people on the road.
4. Mobile phones are one of the biggest driving distractions and can be extremely dangerous.
5. Driving or riding a vehicle when intoxicated is a punishable offense and the strictest among all road safety rules across the globe.
6. Wear necessary safety gear as a road safety precaution.
7. Give way to emergency vehicles such as ambulances and fire brigades to save lives
