NOW, THEREFORE, in consideration of the mutual promises made herein and of good and valuable consideration, the receipt and sufficiency of which both Geethanjali College Of Pharmacy and Vyas Labs hereby acknowledge, Geethanjali College of Pharmacy and Vyas Labs hereby agree to sign a memorandum of understanding (MoU).

I. OBJECTIVES:

- Pharmacology studies on different animals, mainly focusing efficacy models for research
- To implement collaborative R&D activities in the field of Pharmacology
- Interaction with Geethanjali College of Pharmacy through training the faculty and students in latest technologies from time to time

II. JOINT RESPONSIBILITIES

1. Research instrumentation, infrastructure and library facilities available at Vyas Labs and Geethanjali College of Pharmacy shall be made available to the faculty, research scholars and students on case to case basis.
2. The implementation of the areas and forms of cooperation to be identified shall be subject to the availability and convenience of students, faculty and infrastructure facilities available at Vyas Labs and Geethanjali College of Pharmacy.
3. Vyas Labs offers to permit PG students (number depending on available resources) for a period specified period to work on thesis-based programs under the joint supervision of Vyas Labs and Geethanjali College of Pharmacy staff.
4. The Guide/ Co-Guide / Co-Chairman/Member for the students' advisory committee shall be from Vyas Labs or Geethanjali College of Pharmacy depending on the quantum of research activity, the research team will be constituted by Managing Director, Vyas Labs and Principal Geethanjali College of Pharmacy by mutual agreement.
5. Both parties shall nominate members of their respective staff to work out the practical details of cooperation between the two organizations in general and to ensure proper and effective implementation of this MoU.
6. The work plans developed shall be approved by both the parties for implementation.

III. PUBLICATIONS AND INTELLECTUAL PROPERTY RIGHTS

1. Research findings arising out of the students and joint research projects shall be published in public interest jointly with mutual consent, and both parties will be entirely responsible for conclusions and interpretations reported.
2. The procedural formalities for securing and maintaining the intellectual property rights shall be the responsibility of Vyas Labs and the expenditure incurred thereof shall be borne jointly and equally by both parties. When a technology/item is patented, it will be owned by Vyas Labs and Geethanjali College of Pharmacy.
3. Results from collaborative/ integrated research may be used by either or both the parties with due recognition of each party's contribution.

PREAMBLE

Whereas, Geethanjali College of Pharmacy Cheeryal (V), Keesara (M), Medchal (Dist), Telangana 501301 at its various departments is charged with responsibility of training scientific manpower in various front-line areas of importance for the Nation and is also contributing to the rapidly growing and Pharmacological knowledge and professional excellence in Pharmacy by undertaking industrial & applied research and consultancy.

Whereas, Clinical Research Center Mylan Laboratories, Hyderabad is engaged in Clinical Research and manufacturing platforms in India and produce medicines in a wide range of therapeutic areas.

Whereas, both Geethanjali College Of Pharmacy and Mylan Laboratories, Hyderabad, now

- Recognizing the importance of research and development in the area of pharmaceutical sector, as well as imparting industrial training to the Pharmacy students, etc.

- Appreciating the need for creation of large reservoir of highly qualified manpower in all fields related to Pharmacy.
- Desiring to club their efforts by pooling their expertise and resources,

INTEND to form a nucleus for promoting excellent quality manpower in the fields of, and sciences with special emphasis on pharmaceutical sciences and related fields etc.

NOW, THEREFORE, in consideration of the mutual promises made herein and of good and valuable consideration, the receipt and sufficiency of which both Geethanjali College Of Pharmacy and Mylan Laboratories, Hyderabad hereby acknowledge, Geethanjali College Of Pharmacy and Mylan Laboratories, Hyderabad hereby agree to sign a memorandum of understanding (MOU).

ARTICLE-I: SCOPE OF THE MOU

This MOU details the modalities and general conditions regarding collaboration between Geethanjali College Of Pharmacy and Mylan Laboratories, Hyderabad for enhancing, within the country, the availability of highly qualified manpower in the areas of Pharmaceuticals sciences without any prejudice to prevailing rules and regulations in Geethanjali College Of Pharmacy and Mylan Laboratories, Hyderabad approved by the competent authorities under Govt. of India in so far as such mechanism applies to Geethanjali College Of Pharmacy and Mylan Laboratories, Hyderabad. The areas of cooperation can be extended through mutual consent.

ARTICLE-II: SCOPE AND TERMS OF INTERACTIONS

Both Geethanjali College Of Pharmacy and Mylan Laboratories, Hyderabad shall encourage interactions between the pharmacists, Scientists, Research fellows, faculty members and students of both the organizations through the following arrangements:

- a) Exchange of personnel through deputation as per the rules of the respective institute, for limited periods as mutually agreed upon;
- b) Organization of joint conferences and seminars;
- c) Practical training of Geethanjali College Of Pharmacy students at Mylan Laboratories, Hyderabad;
- d) Joint guidance of student projects/thesis in pharmacy and other areas of national interest at Geethanjali College Of Pharmacy by Mylan Laboratories, Hyderabad on mutually agreeable terms.
- e) Mylan Laboratories, Hyderabad would accommodate B.Pharm. Students who have completed the 6th semester of their programme in such a number that Mylan Laboratories, Hyderabad deems convenient to it for the purpose of imparting industrial training.
- f) Mylan Laboratories, Hyderabad may depute its personnel as visiting faculty at Geethanjali College Of Pharmacy to teach any of the regular Course or specialized topics.
- g) Mylan Laboratories, Hyderabad personnel, as well as research scholars, may also be allowed to enroll for their M.Pharm. (Research) at Geethanjali College Of Pharmacy, subject to availability of seats, research facilities and subject to their

fulfilling eligibility criteria and all other academic regulations of Geethanjali College Of Pharmacy. Further, Mylan Laboratories, Hyderabad may request to design and teach a Course or Courses which it deems fit to enhance quality and performance of its employees. Such Courses maybe run at any mutually convenient premises.

- h) Mylan Laboratories, Hyderabad may seek assistance/guidance of Geethanjali College Of Pharmacy faculty member/s in product/process modification, modernization, trouble shooting, etc.
- i) Would allow the industrial visits of students for half/full day to provide them with an exposure to various equipment, instrument, etc.
- j) Mylan Laboratories, Hyderabad may showcase its business activities at the seminar/workshop/conference, etc. at Geethanjali College Of Pharmacy.
- k) Mylan Laboratories, Hyderabad may avail library, Internet, computational facilities at Geethanjali College Of Pharmacy.
- l) Post-graduate student will be allotted a Research supervisor from Geethanjali College Of Pharmacy faculty members. A Research Scientist/pharmacists at Mylan Laboratories, Hyderabad may be appointed a Co- research guide as per the rules of the respective institute for a student Registered for Ph.D/ M.Pharm (Regular or Research) degree at Geethanjali College Of Pharmacy. The student maybe encouraged to take up the project such that Mylan Laboratories, Hyderabad desirably benefits from its outcomes.
- m) The students will carry out part of their research work or M.Pharm./B.Pharm. Project at Geethanjali College Of Pharmacy and Mylan Laboratories, Hyderabad depending on the nature of the work as per rules of the respective institute depending on facilities and requirements.
- n) There will be no restriction on the contents of the thesis and on publication of results of the thesis, subject to the condition that no Intellectual Property Rights can be secured for any part of the work which will be decided with mutual consent.
- o) Both Geethanjali College Of Pharmacy and Mylan Laboratories, Hyderabad will be free to independently carry out follow-up research on the thesis work conducted under this scheme.
- p) If the outcome of a project related to product development, process and design etc. which involves matter of secrecy and concern with security of the State and the Country, the same will not be allowed for publication/printing in any form such as Electronically/verbal, etc. If the outcome of a project results into an intellectual property, for which rights can be secured, it will be decided on case to case basis. Similarly, sharing of expenditure in securing such rights and income accrued through royalty etc by the parties under the law will be decided on case to case basis after mutual consultation.
- q) Research supervisors from both the Institutes will be the corresponding authors in any publication resulting from the collaborative work. All the efforts put by the student/s as a part of this MoU will be accounted for by way of reporting the work in thesis and/or paper publication except the part for which IPR needs be claimed.
- r) Neither of the supervisors will publish the work carried out under this MoU without knowledge of the other.
- s) In any of the activities mentioned above, wherever financial aspects are involved, amount, payment conditions, etc. would be spelt out clearly before starting the activity

- t) In the activities financial obligation and shall be outside the scope of the agreement

ARTICLE-III : SHARING OF FACILITIES

- a) Geethanjali College Of Pharmacy and Mylan Laboratories, Hyderabad shall make provisions to share their respective important R&D facilities in order to promote academic and research interaction in the areas of cooperation.
- b) Geethanjali College Of Pharmacy and Mylan Laboratories, Hyderabad shall permit the sharing software and other materials and components developed in-house in the areas of cooperation, if permissible within the rules governing the two institutions. However, responsibility for safety of chemicals and other materials during the exchange will rest on respective Head of academic department/section.
- c) Geethanjali College Of Pharmacy and Mylan Laboratories, Hyderabad shall provide access to the library facilities to scientists, members of faculty and students as per the prevailing rules and norms in the respective institutes.

ARTICLE-IV: CO-ORDINATION OF THE PROGRAMME INCLUDING FINANCIAL ARRANGEMENTS

- a) The collaborative programme between Geethanjali College Of Pharmacy and Mylan Laboratories, Hyderabad shall be coordinated by a coordination committee appointed by Directors of both the Institutes.
- b) Financial arrangements for each specific collaboration will be decided on a case-to-case basis and brought on record in each case after due approval from heads of both the Institutions.

ARTICLE-V : EFFECTIVE DATE AND DURATION OF MOU

- a) This MOU shall be effective from the date of its approval by competent authorities at both ends.
- b) The duration of the MOU shall be for a period of 5 years from the effective date.
- c) During its tenancy, the MOU may be extended or terminated by a prior notice of not less than six months by either party. However, termination of the MOU will not in any manner affect the interests of the students/faculty/scientists who have been admitted to pursue a programme under the MOU.
- d) Any clause or article of the MOU may be modified or amended by mutual agreement of Mylan Laboratories, Hyderabad and Geethanjali College Of Pharmacy.

ARTICLE-VI : IPR

Rights regarding publications, patents, royalty, ownership of software/design/product developed etc. under the scope of this MOU, shall be decided by the two parties by mutual consent.

ARTICLE-VII: CONFIDENTIALITY

During the tenure of the MOU both Geethanjali College Of Pharmacy and Mylan Laboratories, Hyderabad will maintain strict confidentiality and prevent disclosure of all the information and data exchanged under the scope of this MOU for any purpose other than in accordance with this MOU.

Both Geethanjali College Of Pharmacy and Mylan Laboratories, Hyderabad shall bind their respective personnel who come into possession or knowledge of any confidential information not to disclose the same to third parties without written approval of the disclosing party or use such confidential information for any use other than intended under this agreement or PROJECTS.

Further both Geethanjali College Of Pharmacy and Mylan Laboratories, Hyderabad shall put in place adequate and reasonable measures to keep and store confidential information secure so as to prevent any unauthorized use.

CONFIDENTIAL INFORMATION shall mean any proprietary information, data or facts belonging to PARTIES collectively or severally, disclosed by the disclosing party under this agreement or any subsequent agreement, whether in writing, verbal or electronically, irrespective of the medium in which such information is stored, which is marked confidential or with any other words having similar meaning by the disclosing party, or specifically agreed to be kept confidential by the parties, or declared or identified so by the disclosing party before such disclosure or during the discussions. However confidential information shall not include any data or information which:

- (a) is or becomes publicly available through no fault of the receiving party,
- (b) is already in the rightful possession of the receiving party prior to its receipt of such data or information;
- (c) is independently developed by the receiving party without reference to the confidential information of the disclosing party
- (d) is rightfully obtained by the receiving party from a third party or is in the public domain
- (e) is disclosed with the written consent of the party whose information it is, or
- (f) is disclosed pursuant to court order or other legal compulsion, after providing prior notice to the disclosing party.

ARTICLE-VIII : AMENDMENTS

Any amendment and/or addenda to the AGREEMENT shall be in writing and signed by the PARTIES hereto and shall only after such execution be deemed to form part of the AGREEMENT and have the effect of modifying the AGREEMENT to the extent required by such amendment or addenda.

ARTICLE-IX : RESOLUTION OF DISPUTES

- a) This agreement shall take effect and be construed in accordance with the Laws of India and be subject to the jurisdiction of the courts at Hyderabad.
- b) The dispute or difference whatsoever arises between PARTIES in relation to or in connection with this AGREEMENT both the parties shall first try to resolve the dispute/difference amicably between themselves, failing which the matter shall be referred to and settled through arbitration. The arbitration proceedings shall be held in accordance with the provision of Indian Arbitration and Reconciliation ACT, 1996. The venue of arbitration shall be New Delhi and Language of arbitration shall be English.

ARTICLE-X: MISCELLANEOUS

- a) The headings and sub-headings are inserted for convenience only and shall not affect the construction of this Agreement.
- b) Both Geethanjali College Of Pharmacy and Mylan Laboratories, Hyderabad shall not, during the term of this Agreement directly or indirectly, solicit or offer employment or engagement to any of the personnel of other party without the prior consent in writing of that other party.
- c) No failure to exercise and no delay in exercising, on the part of a Party, and right, remedy, power or privilege hereunder shall operate as a waiver thereof, nor shall any single or partial exercise of any right, remedy, power or privilege hereunder preclude any other or further exercise thereof or the exercise of any other right, remedy, power or privilege. The rights, remedies, power and privileges herein provided are cumulative and not exclusive of any right, remedies, powers and privileges provided by law.
- d) After this Agreement has been signed, all preceding understandings/negotiations and correspondence pertaining to it shall become null and void.

M.Pharm. Program Lab Training:

M.Pharm. students in the specified areas will be visiting Mylan Laboratories, Hyderabad and acquire hands-on experience yearly once for a period of 14 days to get trained in the technologies available at Mylan Laboratories, Hyderabad with nominal charges as per Mylan Laboratories, Hyderabad norms. The schedule of such visits will be pre-decided by both the organizations. Upon successful completion of their training Mylan Laboratories, Hyderabad will issue necessary certificates endorsing the performance of the students.



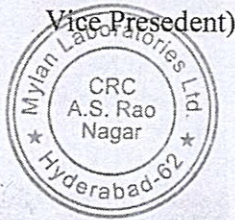

FOURTH - DURATION AND RECINDENCE OF MoU



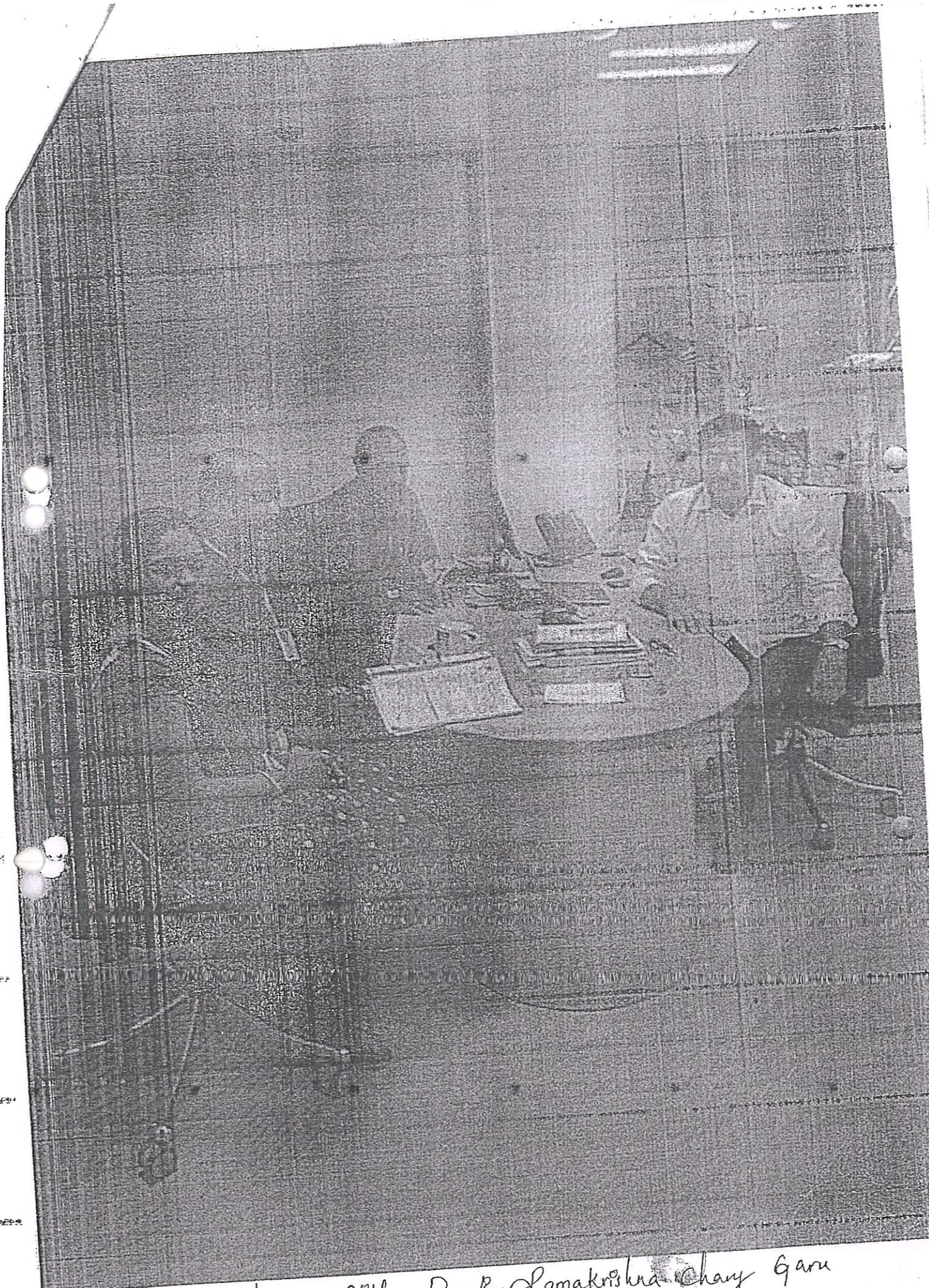

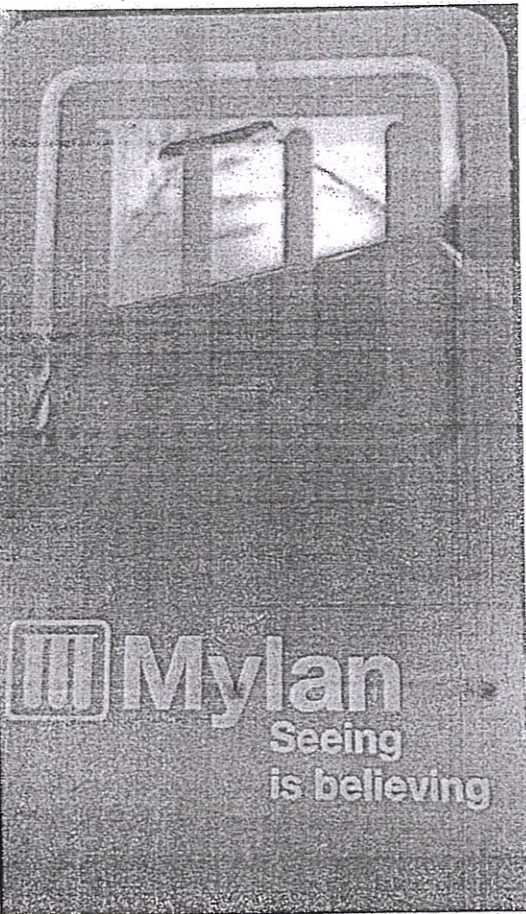
