Complaints regarding ragging can be brought to the notice of the any of the anti ragging committee members, who will take necessary action.

It is the responsibility of the anti ragging squad to monitor and ensure that no ragging incidents will happen in their respective areas. Bus incharges are responsible for ensuring no ragging incidents take place in the buses. All the 1st year students are to be seated in the front seats, then faculty are to be seated. Seniors are to be seated at the back.

PUNISHMENTS: Depending upon the nature and gravity of the offence as established by the Anti Ragging Committee of the college, the possible punishments for those found guilty of ragging at the college level shall be any one or a combination of the following:

RAGGING WITHIN OR OUTSIDE THE COLLEGE CAMPUS IS PROHIBITED

S. No	NATURE OF RAGGING	PUNISHMENT
1	Teasing, Embarrassing and Humiliating	Imprisonment up to 6 months or fine up to Rs.1000/- or both
2	Assaulting or using Criminal force or Criminal Intimidation	Imprisonment up to 1 year or fine up to Rs.2000/- or both
3	Wrong fully Restraining or Confining or Causing Hurts	Imprisonment up to 2 years or fine up to Rs.5000/- or both
4	Causing Grievous Hurt, Kidnapping or Raping un-natural	Imprisonment up to 5 years or fine up to Rs.10000/- or both
5	Causing Death or Abetting Suicide	Imprisonment up to 10 years or fine up to Rs.50000/- or both

Note: A student involved in any of the above offences will be arrested and dismissed from the college and will not be admitted in any other college.

4	Causing Grievous Hurt, Kidnapping or Raping un-natural	Imprisonment up to 5 years or fine up to Rs.10000/- or both
5	Causing Death or Abetting Suicide	Imprisonment up to 10 years or fine up to Rs.50000/- or both

Note: A student involved in any of the above offences will be arrested and dismissed from the college and will not be admitted in any other college.

5	Causing Death or Abetting Suicide	Imprisonment up to 10 years or fine up to Rs.50000/- or both

Note: A student involved in any of the above offences will be arrested and dismissed from the college and will not be admitted in any other college.

4	Causing Grievous Hurt, Kidnapping or Raping un-natural	Imprisonment up to 5 years or fine up to Rs.10000/- or both
5	Causing Death or Abetting Suicide	Imprisonment up to 10 years or fine up to Rs.50000/- or both

Note: A student involved in any of the above offences will be arrested and dismissed from the college and will not be admitted in any other college.

We have taken the following measures to curb the menace of ragging in our college.

1. Anti ragging committee and Anti ragging squads have been constituted with the names and their posting places. The places include college campus, Bus stops, Near by village shopping places etc. The faculty members are instructed to be at their allotted places during the college working hours and after college working hours.
2. The names of the anti ragging committee members and Anti ragging squad members are placed in the college website.
3. Information on what constitutes ragging and punishment for indulging in ragging is displayed at prominent locations in the college premises.
4. Classes for 1st year students are conducting in a separate building (Block – 2), where as the senior students classes are conducted in Block – 1.
5. The lunch hours are staggered to avoid inter timings of students of 1st year and senior students at canteen, library etc.
6. SMS Text messages were sent to parents of senior students of the college informing them to counsel their ward not to indulge in ragging.
7. The first year students are segregated from the senior students in the college buses by making them to sit in the front rows, then the faculty and the senior students in the rear rows. This will be monitored by the faculty as bus in-charges.
8. Additional security guards are posted near the block – 2 where classes for the 1st year students are being conducted, to avoid any interaction of the seniors with the 1st year students.
9. Undertakings are taken from all senior students (as per the UGC format) that they will not involve in any ragging activities.
10. CCTV cameras are installed at vulnerable places to monitor the movements of the senior students.
11. Displayed anti-ragging posters in notice boards and premises of college including college buses.
12. Regular instructions to the students of 1st year and senior students about consequences of ragging are being given.
