2. An Expert Team conducted an on-site evaluation of the program during 04<sup>th</sup>-05<sup>th</sup> January, 2020. The report submitted by the Expert Team was considered by the concerned Committees constituted for the purpose in NBA. 3. It may be noted that only students who graduate during the validity period of accreditation, will be deemed to have graduated with an NBA accredited degree.

4. The program has been granted accreditation for three years. Geethanjali College of Pharmacy, Cheeryala(V), Keesara (M), Rangareddy Dist., Telangana – 501301 should submit the Compliance Report at least six months before the expiry of validity of accreditation mentioned above to be eligible for consideration by the concerned Committee in NBA for further processing of the accreditation status. This could entail further extension of accreditation or a revisit, as deemed appropriate by NBA Committees.
