The division of labour between men and women contributes to the creation of gender roles, which in turn lead to gender-specific social behaviour.

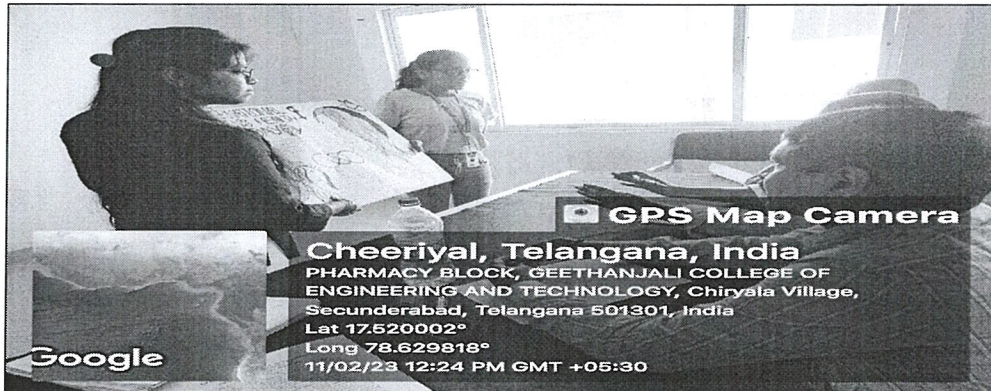
REPORT
